
Solano County is located in northern California, approximately 35 miles west of the state capitol. Solano County has a population of 436,092; close to 23% are under the age of


The Survey


Scientific surveys were recently conducted throughout California to assess product marketing and the availability of healthy and unhealthy options offered in stores that sell tobacco. Surveys were completed in 7,152 stores in all 58 counties and 3 cities in California. Types of stores included convenience, supermarket, liquor, tobacco, small market, discount, and drug stores. This valuable information helps make the places we shop healthier.


18. Approximately 39% of its residents are White/non-Hispanic, 26% of residents are Hispanic, and 30% of its households speak a language other than English at home. Fifty-one percent of all K-12 students qualify for the Free/Reduced Meal Program; 25% of residents have a college degree. For the Healthy Stores campaign, Solano County completed 83 store surveys.
